YOUTH PROTECTION TRAINING THROUGH BSA

NFCYM requires that you complete the online youth protection training course from Boy Scouts of America (BSA) if you are not safe environment trained with your home diocese or sponsoring company/organization.

- 1. Go to https://my.scouting.org
- 2. Click on Create Account.
- 3. Once your account is set up, navigate to the BSA Learn Center, scroll down the page until you see Programs, and click on "Youth Protection Training."
- 4. You must complete either "Mandatory-Youth Protection Training" or "Capacitación de Protección Juvenil– Mandatorio." At a minimum, completing the course takes 72 minutes in English/83 minutes in Spanish.
 - Content will not play automatically. You must click at the end of the content to advance to the next page.
 - You cannot fast-forward, but if you are interrupted, you should be able to resume the training where you stopped.
 - There are Knowledge Checks at the end of each section.
 - Any time the training references the "Scout Executive," you should mentally replace that with the NFCYM Executive Director. Christina Lamas is NFCYM's executive director. She can be reached by phone or text at 202-301-5160.

- 5. The system will generate a certificate 24 to 48 hours after completion. Please download the certificate and email it as instructed.

BACKGROUND SCREENING

NFCYM uses SecureApplicant for screening volunteers and independent contractors. You will need your passport, driver's license, or state-issued identification card to verify your identity.

- 1. Go to https://secureapplicant.com/business/national-federation-for-catholic-youth-ministry-inc/.
- 2. Click on Apply Now.
- 3. Scan the QR code with your phone or tablet's camera **OR** visit https://docupass.app and enter the reference code on the screen.
- 4. Take pictures of your selected identification as instructed and submit.
- 5. Select your role from the list and click Continue.
 - You only need to enter "Alternate Names" if you currently or have used an unrelated alias (ex., Maureen Gross, aka Taylor Swift).
 - NFCYM **cannot** see your personally identifiable information (PII). Only the last four digits of your SSN will appear on any reporting.

It will take approximately five business days for NFCYM to receive your screening results and review them for approval or denial (if charged or convicted of a <u>disqualifying offense</u>).
